

Resources for Tribes using the National Incident Management System (IMS) approach to COVID-19 response

Since March 2020, Tribal nations have mounted pandemic responses by enacting Tribal emergency response plans. These plans typically include protocols delineating measures and necessary precautions in emergencies such as the COVID-19 pandemic. Tribal Leadership can activate Emergency Operation Systems (EOC) and Incident Management Teams (IMT), which play significant roles in providing logistical support, centralizing operations, facilitating communication, and coordinating emergency response resources.

What is an Incident Management System (IMS)?

An Incident Management System (IMS) plans and oversees all levels of pandemic response, working with Tribal, state, and federal organizations and the private sector to prevent and respond to incidents. An IMS can help coordinate a response to COVID-19 and support relief efforts across all sectors within a community. This document provides resources for establishing and maintaining an IMS from various national organizations.

All-Hazard Incident Management Teams (AHIMT) play an essential role in the management of, and response to, local/regional/national emergencies, natural disasters and public events, such as the COVID-19 pandemic. An AHIMT is a comprehensive resource (a team) to either enhance ongoing operations through provision of infrastructure support, or when requested, transition to an incident management function. This document provides an overview over the AHIMT structure.
